Madeline Marczak Principal Clinical Psychologist, CYP-IAPT Parent Training/o-5s Operational Lead Greater Manchester West Cognitive Behaviour Therapy Training Centre

She works as a Clinical Psychologist for the Children and Parent's Service (a specialist o-5 CAMHS Service in Manchester) as well as being Operational Lead for the North West CYP-IAPT Parent Training and o-5s programmes, affiliated with the University of Manchester.

Lead Psychologist for Specialist CAMHS at Greater Manchester Mental health NHS Foundation Trust. Child and Adolescent Representative within the BPS Division of Clinical Psychology, Faculty of Forensic Clinical Psychology. Dr Millington contributes to practice development through various professional and service networks and via publication projects, teaching and presenting.

Garry Blackburn

Garry has almost 20 years of experience working within CAMHS in various settings, including inpatient, outpatient and the community, where he has worked as a manager, Community psychiatric Nurse and CBT therapist. Dr Ross works in Forensic CAMHS (FCAMHS, Northwest), part of Greater Manchester West Mental Health NHS Foundation Trust. He is dual trained in Child and Adolescent Psychiatry and Forensic Psychiatry. I have been working with young people with high-risk forensic behaviours in the context of mental health difficulties since 1997 and as a consultant since 2000. Dr Ross works across a range of settings – community; a medium secure inpatient unit; a secure unit for young people involved with the Criminal Justice System; and a secure unit for young people subject to Secure Accommodation Orders.

Joanna Johnson, Deputy Team Manager, North Lancashire Criminal Justice Liaison & Diversion Team

Joanna Johnson is a Registered Mental Health Nurse with 17 years' experience of working within a variety of both inpatient and community settings; Joanna has also completed the MSc in Personality Disorder at the University of Central Lancashire. During this time she has been privileged with working with a diverse and complex group of service users who are from varying backgrounds and have a multitude of diagnoses.

David Eaton, Service Manager for Blackpool Child and Adolescent Mental Health Service RMN, Dip N, Bsc (Hons), MSc

David first commenced his work in CAMHS at Alder Hey Children's Hospital Liverpool in 1989, both in an inpatient and community setting. David is a founder member of the Association of Primary Mental Health Work and Training CAMHS, and is Chair and Director. David has supported the implementation of several Primary Mental Health Services for CAMHS in the North West and shared his experience with many services across the UK.
